In addition to the advertisement in the daily news paper same may be propagated in electronic media for the awareness of the rural candidates. Allotment will be given on the basis of combined

merit rank as the seats are de-reserved and converted to open category. During allotment, the candidates belonging to ITI / +2 Vocational will be allotted first. After exhaustion of the applied candidates under ITI/ +2 Vocational course, same will be allotted to +2 Science (PCM) candidates.

- Non-reported candidates shall be refunded the admission fee as per AICTE guideline. The
 candidates shall report physically at DTE&T, Odisha on or before dt.18.08.2012 along with
 the proof of Fee deposit receipt issued by NCC and RANK card in Original.
- 4. It was decided to extend the date of Registration, Choice filling, Document verification & Choice locking to dt.25.07.2012 to give an opportunity to the 1st semester left out DET-2012 Rank holders.
- It was decided that, there shall be a vacancy round counseling for Non-Engineering Rank.
 holders, which shall be conducted at BOSE, Cuttack. The date of counseling shall be
 finalized in consultation with Principal, BOSE, Cuttack.
- 6. It was decided to close the admission to branch of Beauty Culture in Govt. Polytechnic, Bhubaneswar, Modern Office Management & GDF&T in Govt. Polytechnic, Dhenkanal and Modern Office Management in SKDAV Govt. Polytechnic, Rourkela. Proposal for taking admission in all branches of Govt. Polytechnics in respect of male candidates after exhaustion of merit list of women candidates shall be submitted to Govt. for consideration.
- 7. The Participating Institutes (PIs) shall be instructed to submit the list of reporting candidates along with the fee deposit receipt issued by NCC in original and Xerox copy of the CLC/ SLC for getting the admission fee from DET Cell, DTE&T, Odisha by dt.18.08.2012 for Lateral Entry candidates.
- Registration number allotted by DTE&T in consultation with NIC and STE&VT shall be issued in a prescribed format which will be available in the SCTE&VT website. All Institutes will download and distribute among the students with the ink signature of the Principal. (Action: VC, SCTE&VT, Odisha)
- The committee approved the additional amount of Rs.404317.00 for payment to the printer towards additional printing cost of question papers for DET-2012. Accordingly Rs.50280.00 more shall be paid to VC, SCTE&VT, Odisha.
- Appropriate steps shall be taken by VC, SCTE&VT, Odisha for publication of Diploma semester examinations and ITI end examinations in time. For any lapses in the matter, responsibility shall be fixed against the concerned staff members. (Action: VC, SCTE&VT)
- 11. Committee approved that allotted candidates in 1st semester admission can deposit their admission fee in cash through AXIS Bank Challan at any AXIS Bank.
