At the outset, the Chairman welcomed all the participants. The members discussed on both long term training programmes and medium / short term training programmes to be undertaken at the Mini Tool Room and Training Centre (MTRTC established by M/s Gram Tarang Employability Training Services Pvt. Ltd. (GTETS under Public Private Partnership (PPP) mode at paralakhemundi.. Besides, name of the courses with duration which are to be incorporated in the course curricula of the Min Tool Room and Training Centre, Paralakhemundi were also discussed. The Genera Manager, Central Tool Room and Training Centre presented the approved course fee for various courses which are being conducted by the Central Tool Room and Training Centre, Bhubaneswar adopted by the CTTC for the year 2012-13 which would remain valid up to 31.3.2013.

After detailed deliberation it was consensually decided that the equipments required for the training courses are almost identical in both CTTC and Mini Tool Room and Training Centre at Paralakhemundi. Over and above, the infrastructure, manpower and faculty/ trainers requirement are almost same in both the Tool Rooms since all courses those are being conducted in CTTC have also been contemplated to be imparted at Mini Tool Room Training Centre, Paralakhemundi.

The M/s Grama Tarang Employability Training Services Pvt. Ltd. (GTETS) shall charge fees from trainees as per the fee structure finalized by the Fee Committee and duly approved by the Government for short-term and long term training programmes keeping the terms and conditions of the Public Private Partnership for the said Mini Tool Room and Training Centre at Parakhemundi in view.

The Fee Structure Committee will meet annually to determine the fees for the succeeding year. The fee determine in the Fee Structure Committee and duly approved by Government shall be effective with effect from the actual training courses commence at the Mini Tool Room and Training Centre, Paralakhemundi and shall remain valid for one year. The fees for the Government sponsored candidates shall be guided as per the terms and conditions of the Public Private Partnership agreement.

Keeping all these aspects in view and unanimous decision was taken to adopt the fee structure of the Central Tool Room and Training Centre, Bhubaneswar in entirety for the courses conducted in the Mini Tool Room and Training Centre, Paralakhemundi. The long term courses and medium/ short term courses along with the training period and fees for 2012-13 are placed at **Annexure-1** which is adopted at par with the Central Tool Room and Training Centre, Bhubaneswar. The above fee structure decided by the Fee Fixation Committee for Mini Tool Room and Training Centre, Paralakhemundi shall come into force after the same is duly approved by the Government.
