The approval is valid for one year only i.e. for the academic session 2012-13. The Society/Trust Institution shall obtain necessary affiliation/ permission from the SCTE&VT, Odisha, Bhubaneswar as per the prescribed schedule of the Admission Authority. The applicant Society/trust Institution shall send information about commencement of the above course to Government. In case the institution could not commence the above

mentioned course for whatsoever reasons during this year, the approval becomes invalid and the applicant Society/Trust shall have to make fresh application to the DTE&T for grant of fresh approval.

The approval has been accorded subject to fulfillment of the following conditions:

1. Adequate faculty members as per the requirement of syllabus shall be recruited.
2. All the required laboratories/workshop/machineries/equipments as per approved syllabus of the SCTE&VT, Odisha, Bhubaneswar must be operational before making admissions.
3. No excess admission shall be made by the institution during the academic year.
4. The approval is valid only for the academic year as mentioned above. If, no further extension of Government approval is received beyond the academic year, this approval letter will not be valid for making any admission for the subsequent years.
5. Name of the institution, name of the trust/society is not allowed to be changed without prior approval of Government. The name and title of the institution should be such that "the emblems and names (Prevention of improper use) Act 1950 of Government of India is not violated in any manner.
6. The institute shall take appropriate measures for prevention of ragging in any form, in pursuance to the order of the Hon'ble Supreme Court passed in Civil Appeal No. (S). 24295/2004 and No.887/2009, if any incident of ragging comes to the notice of the Authority, the concerned student shall be suspended from attending the College immediately and other punishment will be awarded to him/her as per the law.
